Department of Fisheries invites applications for engagement of consultants from eligible persons on Contract Basis for a period up to 31-12-2020 or till the vacant technical posts in the Department are filled on regular basis, whichever is earlier. Terms and Conditions

- (i) The consultant will not be entitled for any kind of allowances and residential accommodation. They will also be not entitled for telephone facilities, transport facilities and staff car.
- (ii) The engagement of the Consultant will be purely on Contract basis.
- (iii) The engagement period for the consultant would be initially for a period upto 31-12-2020 or till the vacant fisheries technical post are filled on regular basis, whichever is earlier. This period may be extended or curtailed subject to review, at the sole discretion of this Department. The age of Sr. Consultant shall not exceed 45 years and that of Jr. Consultants shall not exceed 35 years.
- (iv) The Consultants shall be eligible for 08 days leave during the calendar year. This leave will not be carried forward in case the engagement period is extended by this Department. Also, no payment in lieu of un-utilized leaves will be paid by this Department at the time of expiry of contract.
- (v) The candidate will be required to sign a non-disclosure undertaking and declaration for abiding by the Code of integrity for Public Procurement (CIPP).
- (vi) The Department may terminate the services of Consultants in case he/she is unable to achieve the assigned works within the time-frame or the work assigned to him/her is not satisfactory to the Department or he/she is found to be lacking in honesty and integrity.
- (vii) The Department shall also reserve the right to terminate the services of Consultants at any time without giving any notice and also without assigning any reason. The engagement of consultants will not confer any right on the part of individual for permanent appointment to the post
- (viii) The Consultants may be called to the Office on Saturdays, Sundays and other Gazetted Holidays or may be asked to sit late in the office after office hours, in case of exigencies of work. No extra allowances will be permissible for the same.
- (ix) Consultants may have to undertake domestic tours to carry out assigned tasks/works, if required. Undertaking of domestic tour is subject to the approval of the competent authority and in case such tours TA/DA will be as:- (i) Sr. Consultant will be entitled for journey by Rail(AC-2 tier) or by Air in Economy Class; Hotel accommodation upto Rs.2500/- per day, taxi charges of Rs.500/- per day for local travels and food bills not exceeding Rs.1000/day (ii) Jr. Consultant will be entitled travel by rail (AC 2-tier); Hotel accommodation upto Rs.2000/day, taxi charges of Rs.300/day for local travels and food bills not exceeding Rs.1000/day.
- (x) No TA/DA shall be admissible to the consultants for attending the interview or for taking up the appointment. Consultant will not be allowed any foreign travel at Government expenses.
- (xi) The contractual appointment will be attached with Department of Fisheries located in New Delhi.
- (xii) If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he will be liable for removal from engagement service and such other action as Government may deem necessary.
