GENERAL TERMS AND CONDITIONS

- The contractual appointment will be attached in Department of Fisheries located in New Delhi. The applicant should have retired from Central Govt. Ministries/Departments located in New Delhi, having experience in handling Parliament matters/Hindi Translation working Central Govt. offices. He/She may preferably be a resident of Delhi only.
- II. The consultant will not be entitled for any kind of allowances and residential accommodation. They will also not be entitled to telephone facilities, transport facilities and staff car.
