## **OFFICE MEMORANDUM**

Subject: - Draft National Fisheries Policy (NFP), 2019-comments regarding.

Fisheries and aquaculture remain an important source of food, nutrition, employment and income for millions, especially the rural populations. In fact, the sector provides livelihood to about 14.5 million people at the primary level and almost twice the number along the value chain. The sector has immense potential to double the fishers and fish farmers' incomes, as envisioned by the government. There is need to consolidate the sectoral gains and sustain growth through policy and financial support to accelerate fisheries development in a sustainable, responsible, inclusive and equitable manner.

- In the year 2017, the Department of Fisheries has promulgated the 'National Policy on Marine Fisheries, 2017' through a Gazette Notification on 28th April, 2017. Subsequently, a Draft of the 'National Inland Fisheries and Aquaculture Policy (NIFAP)' was also prepared by a Committee of Experts with stakeholders' consultation. Besides, Mariculture Policy' and a 'Draft National Policy on Post Harvest Processing and Marketing of Fish and Fisheries Products' have also been prepared. For drafting all the above-said three policies for holistic planning and development of fisheries sector, wide consultations were held with all the stake holders including line Ministries/Departments and State/UTs and research institutes etc.
- Subsequently, it has been decided that to prepare an integrated national policy on 3. fisheries rather than bringing in the various fisheries related policies in piecemeal, the Department has reviewed the existing and proposed policies and prepared a consolidated policy, 'The National Fisheries Policy' by integrating the proposed policies, i.e., 'National Inland Fisheries and Aquaculture Policy (NIFAP)' and 'National Mariculture Policy'. A copy of the said policy is attached herewith.
