

- iii. The rates will be valid for the period of 3 years.
- iv. If any items are lost/damaged, the agency will be responsible and amount will be deducted/adjusted accordingly.
- v. Income tax/vat/GST/shall be deducted from the bill as per rule.
- vi. The bill in triplicate may be submitted to this office for making of payment.
- vii. This permission can be withdrawn without assigning any reason at any time without prior notice.
- viii. The contract may be extended further two years subject to satisfactory performance and escalation of 5% per year for next two years on the same terms & conditions.
