ANNEXURE-I

GENERAL TERMS AND CONDITIONS

- 1. The contractual appointment will be attached in Department of Fisheries located in New Delhi. The applicant should have retired from Central Govt. Ministries/Departments located in New Delhi, having experience in cash and Budget matters. He/She may preferably be a resident of Delhi only.
