The undersigned is directed to state that it is proposed to fill up two post of Director, General Central Service Group "A" Gazetted in Pay Band-3 Rs.15600-39100 + Grade Pay Rs.6600/- at **Central Cattle Breeding Farms** under the Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries, by **transfer on deputation basis**. The field of selection and the educational qualification for the post are as under:-

**Transfer on deputation:-** Officers of the Central Government or State Government or Union Territory Administration of Agricultural Universities or Research Institutions :-

- (a)(i) holding analogous posts rendered after appointment thereto on regular basis in the parent cadre or department; or  
(ii) with 5 years' regular service in the grade rendered after appointment thereto on regular basis in the scale of pay of Rs.15600-39100 with Grade Pay of Rs.5400 in PB-3 or equivalent in the parent cadre on department; and  
(iii) with 6 years' service in the grade rendered after appointment thereto on regular basis in the scale of pay of Rs.9300-34800 + Grade Pay of Rs.4800 in PB-2 or equivalent in the parent cadre or department; and  
(b) Possessing the qualifications and experience as follows:-

**ESSENTIAL:-**

- (i) Bachelor's Degree in Veterinary Science or Bachelor's Degree in Veterinary Science and Animal Husbandry as listed in the First or Second Schedule of the Indian Veterinary Council Act (1984);  
(ii) Registration with the Veterinary Council of India or State Veterinary Council under Veterinary Council of India Act (1984);  
(iii) Post Graduate Degree in Animal Breeding and Genetics or Livestock Production and management or Gynecology and Obstetrics;  
(iv) Five years experience as a Veterinary Surgeon in a Veterinary Clinic or Poly Clinic or Cattle Farm.

**DESIRABLE:-**

Doctorate in Genetics and Animal Breeding or Livestock Production and Management or Gynecology and Obstetrics.

(Period of deputation (including short term contract) period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed 4 (four) years. The maximum age limit for appointment by deputation (including short term contract shall not exceed 56 years as on the closing date of receipt of applications).

**DUTIES FOR THE POST OF DIRECTOR:-**


- To plan, implement and supervise all operational and development activities of the farm.
- Co-ordination of the activities of the various Sections of the farm.
- To function as DDO, control of budgetary allocations.
- To look after the welfare of all the staff members and settle grievances in order to have better staff cooperation.
- Preparation of various Technical reports.
- To function as appointment/controlling/disciplinary authority.

2. **The pay of the officers selected for appointment will be regulated** in accordance with the instructions contained in the Ministry of Finance (Department of Expenditure) O.M.No.15(7)/10/86 dated 13<sup>th</sup> March, 1987 or such general/special orders issued or that may be issued by the Ministry from time to time. The officer selected will have the option to draw his grade pay plus deputation (Duty) allowance or to have his pay fixed in the Pay Band and Grade Pay of the post in accordance with the DOPT OM No.2/12/87-Estt.(Pay-II) dated 29/01/1988 as amended from time to time.

3. Application in duplicate, in the enclosed proforma along with the complete up-to-date ACR dossier of officers who are willing to be considered and can be spared, in the event of their selection, may be sent to this Department. While forwarding applications, it may be verified and certified that particulars furnished by the candidates are correct and that no vigilance case is either pending or contemplated against them and their integrity is beyond doubt. **Applications should reach this Department within 60 days from the date of publication of advertisement in the Employment News/Rozgar Samachar.** Applications received after the due date or found incomplete will not be considered.

4. The number of vacancies may increase or decrease as per administrative feasibility.


