Officers under the Central or State Governments or UTs or Recognized Research Institutions or Public Sector Undertakings or Autonomous Organizations fulfilling the following requirements and terms and conditions:-

- Service requirement- (A)(i)** holding analogous posts on regular basis in the parent cadre or department; or
- (ii) with eight years regular service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 9,300-34,800 with grade pay of Rs. 4200 in the pay band-2 or equivalent in the parent cadre or department;
- (B) Possessing the following educational qualifications and experience:

**“Essential:**

- (i) Post Graduate degree in Agriculture or Agronomy or Masters degree in Science in Dairying with Forage Production as a subject from a recognized University;
- (ii) three years experience in planning and organisation of fodder farming or research or extension work in fodder production in any Central Government organisation or State Government organisation, public sector undertaking or autonomous body or Semi-Government organisation or recognized institute.


