**Sub:** Release of Central assistance for Establishment and Strengthening of Veterinary Hospitals/ Dispensaries a component of Centrally Sponsored Scheme 'Livestock Health and Disease Control- to the State Government of Chhattisgarh during the year 2017-18 -Reg.

**Sir,**

I am directed to refer to the subject cited above and to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs. 103.68 lakh (Rupees One Crore three lakh and sixty-eight thousand and ~~five hundred only~~) as fourth instalment for the continuity of the approved project for construction of Veterinary Hospitals and Dispensaries to the State of Chhattisgarh under 'ESVHD' a component of 'Livestock Health and Disease Control' ESVHD of Central assistance for the current Financial Year (2017-18) with the condition that 40% matching share will be provided by the State Government.

2. The Grants-in-Aid of Rs. 103.68 lakh (Rupees One Crore three lakh and sixty-eight thousand and ~~five hundred only~~) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the Chhattisgarh State Government is subject to the condition that the next instalment for release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the Chhattisgarh State Government.




