sensitized the stakeholders on compliance of CAA Guidelines in coastal districts of Tamil Nadu, Andhra Pradesh, West Bengal and Odisha.

- 23. The Central Institute of Fisheries Nautical and Engineering Training (CIFNET) conducted 12 training courses which include 3 regular courses and 8 short term courses for fishermen outreach training programme benefiting 379 candidates.
- 24. The National Institute of Fisheries Post Harvest Technology and Training (NIFPHATT) conducted training programme on post-harvest management for 67 marine fisher women/ men.
- 25. The Grievance disposal under the CPGRAMS Portal for Department of Fisheries stood at 96% as on 31<sup>st</sup> May, 2024.
