Significant developments during the month of October, 2024 in the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying

- The Department of Fisheries organized a workshop on "Application and Demonstration of Drone Technology in Fisheries and Aquaculture" on 19th October 2024 at Gyan Bhawan, Patna, Bihar. The event was graced by Shri Nitish Kumar, Chief Minister, Bihar along with Shri Rajiv Ranjan Singh, alias Lalan Singh Union Minister, Ministry of Fisheries, Animal Husbandry and Dairying (MoFAH&D) and Ministry of Panchayat Raj, Smt. Renu Devi, Minister Animal and Fisheries Resource Department, Bihar, Shri Vijay Kumar Sinha, Deputy Chief Minister, Bihar, Shri Samrat Choudhary, Deputy Chief Minister, Bihar and other esteemed dignitaries. The workshop brought together scientists, state fisheries officials, fishermen and fisherwomen on one platform to showcase use of drone technology in the fisheries and aquaculture sector.
- 2. The Department of Fisheries through "Vessel Communication and Support System" featuring indigenous transponder technology, has demonstrated its capability in safeguarding fishermen during Cyclone DANA encountered at off Odisha coast in Bay of Bengal. Through these transponders, advisories were issued to the fishermen out at sea through Space Application Centre (SAC), Ahmedabad to avoid venturing into the sea from 21st October to 26th October 2024. It was also advised to the fishermen out at sea to return to the shore immediately. The timing of this warning was significant, allowing fishermen to take necessary precautions before the cyclone made landfall. The messages sent to fishermen included, "Fishermen out at sea are advised to return to the coast immediately," and "Fishermen are advised not to venture into the sea off Odisha Coast and adjoining North Bay of Bengal during that period." These broadcast messages were communicated in both English and Odia to ensure that all fishermen could understand the severity of the situation.
- 3. The Secretary, Department of Fisheries attended a meeting of the Indo-Sri Lank Joint Working Group (JWG) on Fishermen issues from 28th to 30th October, 2024 in Colombo, Sri Lanka. The humanitarian approach in handling fishermen issue, early release of apprehended Indian fishermen and fishing vessels, investigations on death of fishermen, and India's developmental and R&D projects related to fishing and aquaculture in Sri Lanka were discussed.
- 4. The National Fisheries Development Board (NFDB) conducted the 65th Project Appraisal Committee (PAC) meeting on 04th October, 2024 to discuss and evaluate additional proposals and recommended the proposals with total cost of Rs. 305.03 crore, with a central share of Rs. 160.76 crore from Mizoram, Madhya Pradesh, Kerala, Odisha, Gujarat, and Telangana under the Centrally Sponsored Scheme (CSS) of beneficiary-oriented and nonbeneficiary-oriented schemes.
