I am directed to say that one post of Chief Instructor (Marine Engineering) in the pay band- 3 Rs.15600-39100 with Grade pay of Rs.6600/- in Central Institute of Fisheries Nautical and Engineering Training, Cochin is proposed to be filled up on deputation basis (including short term contract) from amongst the Officers of the Central Government or State Governments or Union Territories or recognized Research Institutions or Public Sector undertaking or Universities or Semi Government or Autonomous or Statutory bodies:-

- (a) (i) holding analogous post on regular basis in the parent cadre or Department; or
- (ii) with five years' service in the grade rendered after appointment thereto on regular basis in posts in the Pay Band-3 pay scale of Rs.15600-39100+ Grade Pay of Rs.5400 or equivalent in the parent Cadre or Department; and
- (b) possessing the following educational qualifications and experience:

Essential:

- (a) Degree in Mechanical Engineering or Marine Engineering or Automobile Engineering from a recognized University or Institution with five years experience in operation, maintenance, troubleshooting of marine diesel engines, auxiliaries, ship board marine mechanical equipments, or
- (b) Marine engineering officer Class II (Motor) Certificate of Competency issued by the Ministry of Shipping, Mercantile Marine Department and a Bachelor degree from a recognized university with either one year experience as Marine Engineer officer Class-I or three years experience as Marine Engineer Officer Class II or five years experience as Marine engineer officer Class III of an ocean going ship.

Note I: The departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.

Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date for receipt of applications.

Note: 3: For the purpose of appointment on deputation or absorption basis, the service rendered on regular basis by an officer prior to 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any up-gradation.

Job description: To lead and organize the activities of the Marine Engineering Division, Workshop, Technical Labs (as assigned), works related to Fishing Vessel, Engaging class in Marine Engineering subject and refrigeration etc, of the training programmes, both theoretical, demonstrative and practical.

Preparation of vicious study materials on the subject, undertake fishing cruise as shore officer participant along with the trainees for imparting practical sea training, arranging seminars and workshops and guidance of Project work etc., represent in various committees, associate with the training activities, any other duties assigned by the superiors as per the requirements of the Institute.

The place of posting will be at CIFNET Visakhapatnam.

- 2. The pay of the official selected will be governed by the provisions laid down in the Department of Personnel and Training's O.M.No.6/8/2009-Estt (pay II) dated 17th June 2010 as amended from time to time.
